

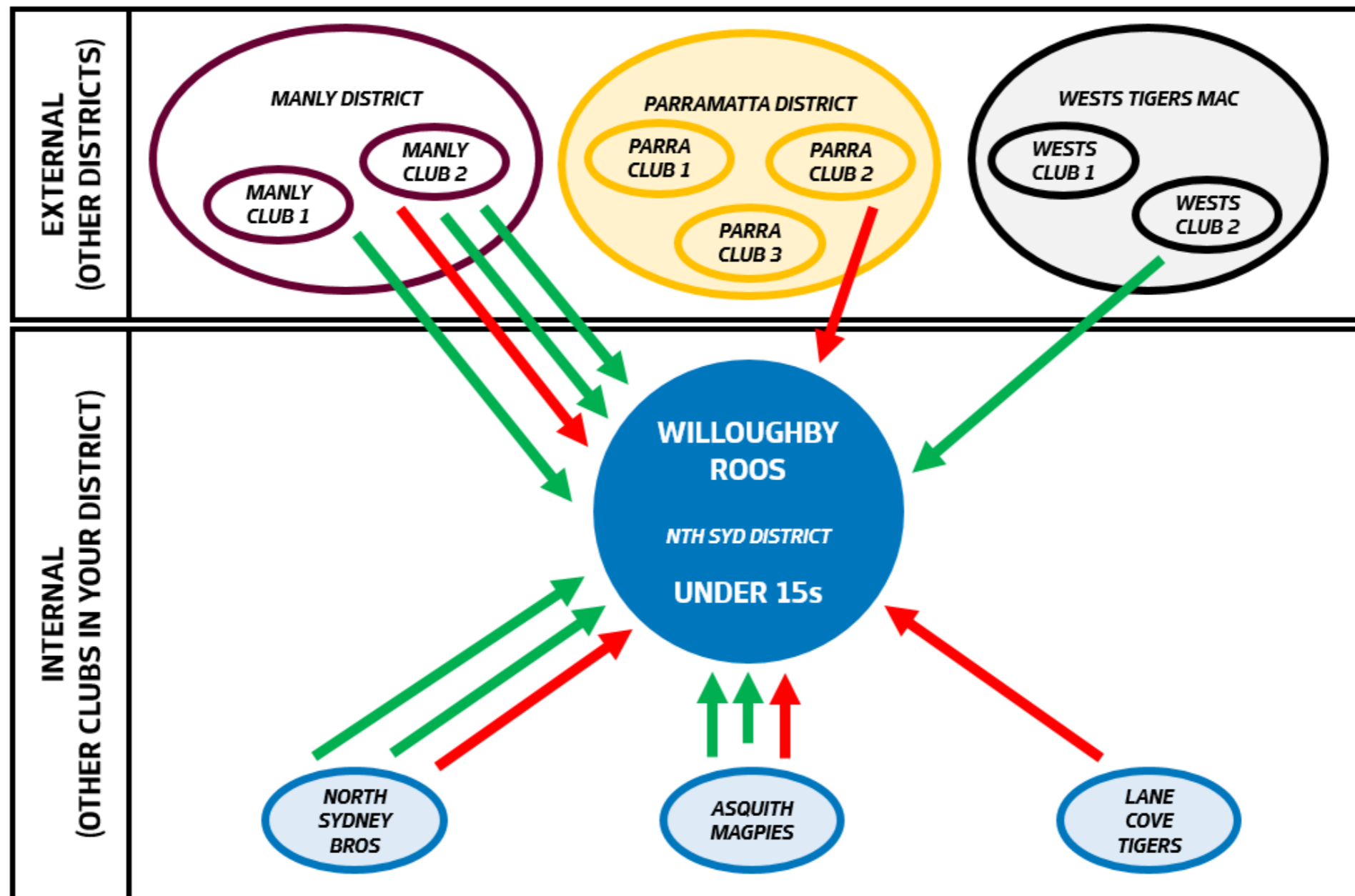
# NSWRL TRANSFER POLICY



EACH TEAM CAN TRANSFER A MAXIMUM OF 8 PLAYERS INTO THEIR TEAM IN ANY ONE SEASON

INTERNAL (SAME DISTRICT) – 4 ALLOWED WITH MAXIMUM OF 2 FROM ANY ONE CLUB IN ANY ONE AGE GROUP  
 EXTERNAL (DIFFERENT DISTRICTS) – 4 ALLOWED WITH A MAXIMUM OF 2 FROM ANY ONE CLUB IN ANY ONE AGE GROUP

TRANSFER POLICY DOES NOT APPLY TO PLAYERS BORN 2002 AND EARLIER (IN 2020)  
 ALL TRANSFERS WILL BE APPROVED IN CHRONOLOGICAL ORDER



## EXTERNAL TRANSFERS

FIRST TRANSFER FROM MANLY CLUB 1 IS **APPROVED**

TWO MORE TRANSFERS FROM MANLY CLUB 2 ARE ALSO **APPROVED**

THE THIRD TRANSFER FROM MANLY CLUB 2 WOULD BE **DENIED** AS IT IS MORE THAN THE MAXIMUM OF TWO FROM ANY ONE CLUB TO ANY ONE AGE GROUP IN ANOTHER CLUB

TRANSFER FROM WESTS CLUB 2 WOULD BE **APPROVED** AS IT IS THE FOURTH EXTERNAL TRANSFER IN TOTAL

TRANSFER FROM PARRAMATTA CLUB 2 WOULD BE **DENIED** AS IT WOULD BE THE FIFTH EXTERNAL TRANSFER

## INTERNAL TRANSFERS

THE FIRST TWO TRANSFERS FROM NORTH SYDNEY BROS TO WILLOUGHBY ARE **APPROVED** – THE THIRD IS **DENIED** AS ONLY TWO PLAYERS FROM ONE TEAM FROM ONE CLUB TO ANOTHER TEAM AT ANOTHER LOCAL CLUB ARE ALLOWED UNDER THE POLICY

TWO MORE ARE **APPROVED** FROM ASQUITH – AGAIN THE THIRD IS **DENIED** AS ONLY TWO PLAYERS FROM ONE TEAM FROM ONE CLUB TO ANOTHER TEAM AT ANOTHER LOCAL CLUB ARE ALLOWED – ALSO WOULD BE **DENIED** AS IT WOULD BE THE FIFTH INTERNAL TRANSFER

TRANSFER FROM LANE COVE WOULD BE **DENIED** AS IT IS THE FIFTH INTERNAL TRANSFER
